## Election of a Greater London Assembly Member for the Havering and Redbridge Constituency

---

- (1) If the election is contested, the poll will take place on **Thursday 2<sup>nd</sup> May 2024**.
- (2) Nomination Forms for this election may be obtained from the Constituency Returning Officer, Election Services, Town Hall, Main Road, Romford, RM1 3BD.
- (3) Nomination papers must be delivered to the Constituency Returning Officer, Election Services, Town Hall, Main Road, Romford, RM1 3BD between the hours of 10am and 4pm on or after the date of this notice (excluding weekends and bank holidays), but not later than **4pm on Wednesday 27<sup>th</sup> March 2024**.
- (4) Nomination papers must be accompanied by a deposit of £1,000, which may be made either in legal tender or in the form of a banker's draft (made payable to Returning Officer Havering).
- (5) Applications to register to vote must reach the relevant Electoral Registration Officer \*\* by **midnight on the Tuesday 16<sup>th</sup> April 2024**. Applications can be made online at [www.gov.uk/register tovot e](http://www.gov.uk/register tovot e).
- (6) Applications to vote by post or to change existing postal or proxy arrangements must reach the Electoral Registration Officer \*\* by **5pm Wednesday 17<sup>th</sup> April 2021**. Applications can be made online at [www.gov.uk/apply-postal-vot e](http://www.gov.uk/apply-postal-vot e).
- (7) Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the relevant Electoral Registration Officer\*\* by 5pm on **Wednesday 24<sup>th</sup> April 2024**. - (8) New applications to vote by proxy must reach the relevant Electoral Registration Officer \*\* by **5pm Wednesday 24<sup>th</sup> April 2024**. Applications can be made online at [www.gov.uk/apply-proxy-vot e](http://www.gov.uk/apply-proxy-vot e).
- (9) Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the relevant Electoral Registration Officer \*\* by **5pm on Thursday 2<sup>nd</sup> May 2024**.
  - a) The physical incapacity must have occurred after 5pm on **Wednesday 24<sup>th</sup> April 2024**.
  - b) To apply on the grounds of work/service the person must have become aware that they cannot go to the polling station in person after **5pm on Wednesday 24<sup>th</sup> April 2024**.
