- iii) Do the strategic sites meet any of the 5 purposes of the Green Belt in paragraph 80 of the NPPF? Do exceptional circumstances exist?
- iv) Has there been any material change in circumstances since the original designation of the Green Belt?
- v) Having regard to paragraph 74 of the NPPF would the loss of existing open space, sports and recreation buildings and land at Ford Sports Ground be replaced by equivalent or better provision in terms of quantity and quality in a suitable location?

- vi) How will the cost of re-provision of Ford Sports Ground and future maintenance be funded?
- vii) How will the transition between existing and new facilities be controlled and managed?
- viii) Would there be significant adverse transport impacts arising from the development of the strategic sites?
- ix) Are schools required on each of the allocated strategic sites?
- x) Is the expectation of a decentralised energy network at King George and Goodmayes Hospitals justified?
