- (4) Nomination papers must be accompanied by a deposit of £1,000, which may be made either in legal tender or in the form of a banker's draft (made payable to Returning Officer Havering).

  - a) The physical incapacity must have occured after 5pm on Wednesday 24th April 2024.
  - b) To apply on the grounds of work/service the person must have become aware that they cannot go to the polling station in person after **5pm on Wednesday 24**<sup>th</sup> **April 2024.**
