- **a person representing persons who satisfy the above**

- **preventing gambling from being a source of crime or disorder, being associated with crime or disorder or being used to support crime.**
- **ensuring that gambling is conducted in a fair and open way**
- **protecting children and other vulnerable persons from being harmed or exploited by gambling**
