**\*This is not a cumulative application fee. Only one application fee is payable regardless of the number of categories you apply for.**

**Example 1. New application for categories 2 & 3:**

New Category 2 Application fee of £665 plus Cat 3 fee of £134.55 = total fee payable £799.55

**Example 2. New application for categories 1, 2 & 3**

New application fee of Cat 1 £934 plus Licence Cat 2 fee of £212.75 plus Licence Cat 3 fee of £134.55 = £1281.30

**All licences expire 31<sup>st</sup> October each year.**

**New licence fees are pro rata to a minimum of 6 months and a maximum of 18 months.**

**Example 3: New application received in May - Fee would be  $\frac{6}{12}$  of total fee.**

**Example 4: New application received in July – Fee would be  $\frac{16}{12}$  of total fee.**

**Example 5: Variation to add a new Category 3 treatment to an existing Cat 2 licence  
Variation fee £197.75 plus Licence Cat 3 fee of £134.55**

**Fees effective from 1 April 2025**
