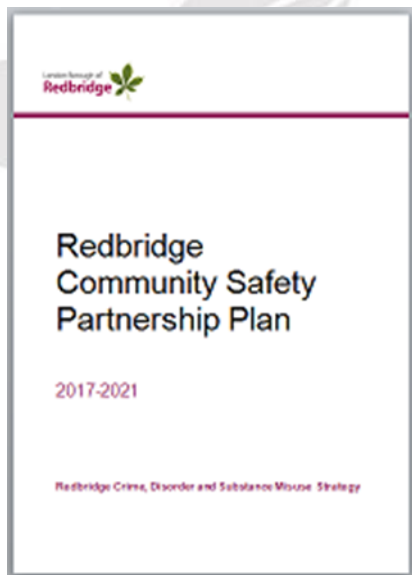

Redbridge Safer Communities Partnership Partnership Plan Priorities



The agreed priorities of the Community Safety Partnership for 2017-21 are:

- **Safeguarding Victims**
(Including: VAWG, Hate Crime & Repeat Victims)
- **Reducing Vulnerability to Offend**
(Including: Gangs, IOM and Drug & Alcohol related ASB)
- **Civic Pride**
(Including: Encouraging Civic Pride & Enforcing Civic Pride)
- **Residential Burglary**

Violence Against Women and Girls



- The MARAC dealt with 329 high risk cases, putting in place multi-agency responses
- Integrated Support Service provided for Council by REFUGE, supporting around 1,000 people per year
- 5 IDVA's provide support
- Additional 2.5 IDVA's paid for by Mayor's Office
- Satellite sessions provided in Schools
- Improved links with substance abuse services



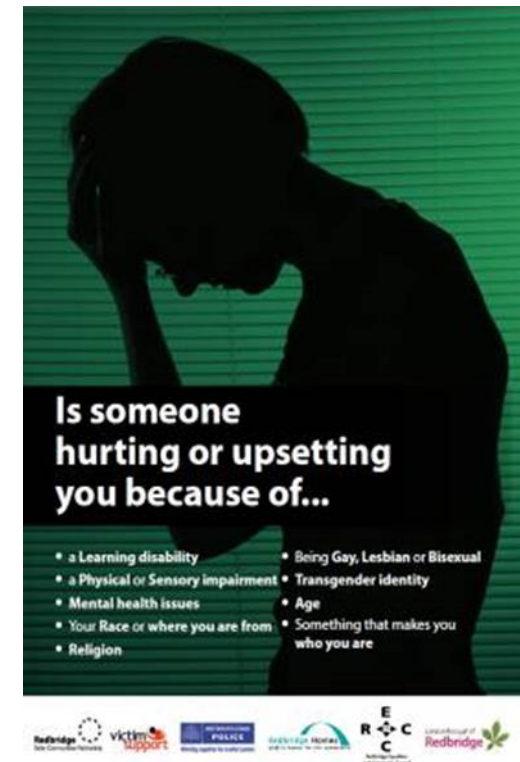
Prostitution

- Targeting of Kerb crawlers
- Built intelligence picture of those co-ordinating activity
- Use of Dispersal Zone
- Use of cautions for those women involved in prostitution not engaging
- CPN's issued to those who continue to solicit
- Outreach support provided through REFUGE service to the women involved in prostitution
- Signposting and provision of safety advise to the women involved in prostitution
- Borough wide PSPO consultation



Hate Crime and Repeat Victims

- Continued to run the Redbridge Victims Panel to put in place a response for repeat and vulnerable victims of hate crime and ASB
- Panel heard 9 cases and signposted a further 4 to other support.
- Supporting RECC with Community Witness and Support Team and hotspot identification
- Information and publicity campaigns
- Established new Community Network for community tension concerns



Licensing Compliance and ASB



- Proactive regulate Licensed premises, over 680 visits conducted through FY
- Weekly tasking monitors the 'top 10' problem premises for monitoring and enforcement activity
- Test purchase operations for age restricted products
- Enforcement of alcohol and town centre PSPO's
- Weekly multi-agency tasking meeting to coordinate joint responses to a variety of issues including ASB



Drug and Alcohol Treatment Services

- Operate arrest referral scheme
- Continued to work with Public Health Redbridge to provide intervention to offenders around alcohol and drug misuse:
 - Drug Rehabilitation Requirement – 23 clients
 - Alcohol Treatment Requirement – 19 clients
- Redbridge “Fusion” team continue to work with young people



Gangs & Integrated Offender Management (IOM)

- Delivered recommendations of 2016 independent gangs locality review – gangs panel; analysis/identification; training; better identification and integration; gang diversion services identified and commissioned
- Over 100 professionals given awareness training around gangs
- Two high profile multi-agency operations to target and disrupt gang activity – Ilford Station and Forterie Gdns
- Partnership continues to operate a number of multi-agency case panels to monitor and manage offenders
- New offender management task and finish group established to identify best management process for offenders



Youth Offending and Targeted Prevention Service

- Continued to operate the 'Deter Young Offender Management Board' to manage young offenders at highest risk of offending
- Saw a 31% reduction in first time entrants into the youth justice system to 49 individuals
- Continued increase in gang affected nominals on caseload due to out of borough referrals which is effecting reoffending
- Young offenders engaged in suitable ETE increased from 77% in 2016/17 to 84.1% in 2017/18



Our Streets Strategy

“Encouraging & Enforcing Civic Pride” complement and directly contribute to the following priorities in the **“Our Street Strategy”**

- **“Clean Streets”** through the behavioural change programme and enforcement of fly tipping etc
- **“Safe Streets”** by enforcing PSPO’s, RADs and other multi-agency partnership activity
- **“Vibrant Streets”** contributing to community clean ups
- **“Attractive Streets”** by addressing untidy front gardens and working with landlords to maintain properties
- **“Streets for Business”** by working with companies to make them aware of their responsibilities on waste



Encouraging Civic Pride

- Development of communications and engagement plan to encourage residents to take greater pride
- Over 1,000 residents engaged with through events, workshops and school sessions
- 18 sessions conducted in schools with a number including litter picks involving the school children
- Activity organised for “Go Green Week” and “Great British Spring Clean”
- Contributed to variety of independent and business lead litter picks

Furniture flytipper left with £450 bill

A man has been forced to shell out £450 after flytipping old furniture that he no longer wanted.

Nikolaj Zubenko, 59, from Breamore Road, Seven Kings was seen dumping chairs, a sofa, and a chest of drawers from the rear of his ground floor flat through a side gate, onto Lyndon Gardens.

He also dumped a shopping trolley with paint pots and a small fridge freezer.

Redbridge Council's enforcement team questioned Zubenko about the rubbish and he admitted dumping them, as he no longer wanted them.

After failing to attend Barkingside Magistrates' Court in September, Zubenko was arrested on February 26 and bailed to reappear on March 17.

He told the court he was disabled and unable to work, had no income, and not in receipt of benefits.

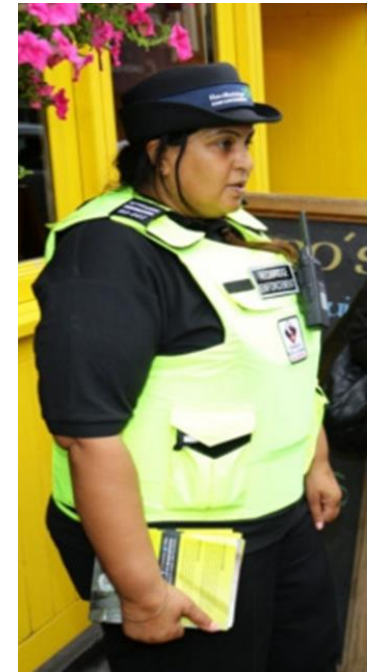
Zubenko was fined £120, ordered to pay £300 towards prosecution costs and a victim's surcharge of £30.



Operations and Redbridge Action Days

Six Redbridge Action Days carried out during 2017/18

- **RAD 21:** HMO Visits-May 2017
- **RAD 23:** Prostitution-June 2017
- **RAD 24:** Town Centre-July 2017
- **RAD 25:** Epping Forest Littering, ASB & Parking – Sept 2017
- **RAD 26:** Valentines Park-October 2017
- **RAD 27:** Acid and Corrosive Substances Project
- **Test Purchase Operations:** targeting Alcohol, Tobacco & E-cigarettes, Knives, Gambling and Firework sales.
- **Multiple Operation Liberal days:** Ilford Town Centre - vehicle stops and trade waste checks.
- **Pigeon Feeder and Plain Clothes Operations:** targeted operations by REO's to address agreed specific issues.

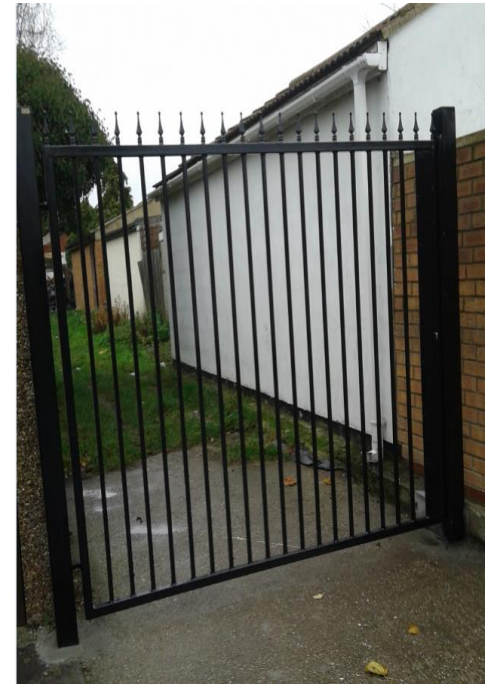


Residential Burglary

- During 2017 total burglary increased by 51% (or 1,015 crimes) compared to 2016
- While **residential burglary** increased by 58% (or 880 crimes) compared to 2016

Activity:

- Creation of designated team of officers focusing on burglary and known offenders Op Mexico– formed Jan 2018.
- Continued support of Neighbourhood Watch & OWL.
- Community Safety Fund £50k
- Continued support of Bogus Caller Partnership
- 5 Alley gating schemes received, 1 complete, 2 agreed, 2 in process.



Bogus Caller Partnership



- Maintained the established “Restricted Calling Zones
- Work with Banks and Building societies to reduce older and vulnerable residents becoming victim of crime
- Distributed nearly 5,000 “No Cold Callers” sticker packs
- Produced and distributed 1,800 calendars for vulnerable residents with advice and contact numbers

Additional Work Carried Out During 2017/18

- Launch of the Ilford Town Centre Public Space Protection Order (PSPO) to provide greater control of activities in Ilford Town Centre
- Implement new PSPO's to replace 'Dog Control Orders' and 'Controlled Drinking Zones' across the Borough
- Civil injunction to improve response time to "Trespasser Incursions" in the Borough
- Location based approach adopted working within the Rough Sleepers Protocol
