The inclusion of HV05 Rainham Recycling Facility (RRF) in the ELJWP is supported. The existing established facility provides an important point for the management of C, D & E waste, i.e. hard inert materials.

RRF is also an active and long-established mineral processing site which is well positioned to receive locally generated inert materials. Those hard inert materials are crushed and screened and exported as useable secondly aggregate with soft materials such as soils and sub-soils segregated and used by Brett Aggregates Limited in the restoration of the company's existing and future mineral workings (refer to accompanying representation).
